2024 Grand Prize Super Scanner Sweepstakes Rules and Regulations

The Grand Prize Super Scanner Sweepstakes is open to all residents of Canada who are active NielsenIQ Homescan Consumer Panelists and have reached the age of majority in the province in which they reside. How to enter:

Each household that transmits purchase data pertaining to their shopping habits in every Homescan week (Sunday 12:00 a.m. ET to Saturday 11:59 p.m. ET) during any given quarter* as outlined above will be entered once (1) into the Grand Prize Super Scanner Sweepstakes. No purchase from NielsenlQ is necessary. Alternatively, if a weekly transmission is missed, or to enter without purchase, a member can qualify for a Grand Prize Super Scanner Sweepstakes quarter by submitting an original hand-written 100-word essay regarding "The Importance of Market Research as it affects the Consumer and the Manufacturer" to NielsenlQ - Grand Prize Super Scanner Sweepstakes, P.O.
